### The floods of 2025. What can we say?

The ripple effect of the floods has been both negative and positive. The devastation, loss of homes, livelihoods, livestock and infrastructure, the mess and the work to keep cleaning up, and the sheer overwhelm and exhaustion some people are feeling cannot be put in words.

On the flip side, the support from neighbours, friends, families and strangers, has been heartwarming. We have had food and water donated by individuals and church groups, by schools and community volunteer groups. We have had people on tractors and diggers, people donating firewood, people clearing driveways and fences and people offering accommodation. We have been given vouchers and meals, and we have had messages of support from around the country.

The Taskforce Kiwi team who stayed at school overnight on Friday and cared for people who were either evacuated or stranded were amazing, as were the Civil Defence RT2 team who came to support during the day.

Thank goodness for the police and our local Fire Party, who were incredibly active around Ngatimoti on Friday evening and Saturday.





Special thanks to the team co-ordinated by Carol Fowler the Motueka attendance officer, for delivering food and blankets to school. Thanks also to the Red Cross, Mitre 10, the Rapid Relief Team, Lions and Rotary, who have all been actively supporting the Ngatimoti community.

This week our school value of RESPECT is all about thinking of others, and this has been evident in so many ways during this crisis.

Thank you to those who have been able to support others, and especially those who have talked with their children about the service to others. Many children love to receive but equally it has been wonderful to see some students eager to give their kind thoughts and help to others. Huge thanks to the St Joseph's school in Nelson, who came out today to give us all a free sausage sizzle for lunch. Wow - how kind!

On Monday the Junior Class made paper flowers and delivered some baking to our school neighbours, John and Margo (right). Please reach out and ask for help if you need it. ## Ngatimoti School Board Elections

### **Parent Election Notice**



Nominations are open for the election of 4 parent representatives to the school board.

All eligible voters will receive a nomination form. Use this form to nominate yourself or someone in your community (with their permission). Information on who is not eligible to be a board member is provided with this notice, and the nomination form.

You do not need anyone else to nominate you. You can nominate yourself.

If you need more nomination forms, contact the school office.

Please note, if you are a current board member and wish to continue on the board, you will still need to submit a nomination form.

Nominations close at **noon** on **Wednesday 6 August**.

### Candidate Statement

If you are a candidate, you are invited to submit an optional statement (up to 400 words) and photo. Make sure your statement is received by noon on 6 August so that it can be sent to voters with the voting papers.

The returning officer may remove or edit any part of the candidate's statement if it exceeds 400 words or is offensive or defamatory.

The electoral roll is held at the school and can be viewed during normal school hours.

As nominations are received, there will be a list of candidates' names kept at the school up until election day, which you can view.

Voting closes at **4pm** on 10 September.

### People who are not eligible to be school board members

The following people are not eligible to be school board

members. A person who:

- is an undischarged bankrupt; or
- is prohibited from being a director or promoter of, or being concerned or taking part in the management of, an incorporated or unincorporated body under the <u>Companies</u> <u>Act 1993</u>, or the <u>Financial Markets Conduct Act 2013</u>, or the <u>Takeovers Act 1993</u>; or
- is a permanently appointed member of the Board staff, unless they are standing for election as a staff representative; or
- contracts or sub-contracts with the Board without the approval of the Secretary of Education and receives payments exceeding \$25,000 in any financial year. This would also cover situations where a person has a 10% or more shareholding in the contracting company or a company that controls the contracting company; or
- is subject to a property order under the <u>Protection of Personal and Property Rights</u> <u>Act 1988</u>; or
- has been convicted of a specified offence identified in <u>Schedule 2</u> of the Children's Act 2014, unless that person has obtained a pardon or been granted an exemption; or
- is a person in respect of whom a personal order has been made under that Act that either the person is not competent to manage his or her own property affairs, or does not have the capacity to communicate/make decisions relating to his/her welfare/personal care; or
- is a person who has been convicted of an offence punishable by imprisonment for 2 years or more, or who has been sentenced to imprisonment for any other offence, unless that person has obtained a pardon, served the sentence, or otherwise suffered the penalty imposed on the person; or
- is not a New Zealand citizen, and is
  - ▶ a person to whom <u>section 15</u> or <u>16</u> of the Immigration Act 2009 applies; or
  - a person obliged, by or pursuant to that Act, to leave New Zealand immediately or within a specified time, being a time that was less than 12 months; or
  - > deemed for the purposes of that Act to be in New Zealand unlawfully.

A returning officer for an election (or by elections) of board members is not eligible to be nominated as a candidate in that election.
